We need to get what we possibly can where we can, without endangering the business relationship and health of everyone.

#### **New Business**

- Switch & Grind Coffee Candace began the discussion of new business, starting with the new coffee shop. They originally wanted to open by the first week of October. However, it's looking like it will be more towards the middle of October. They have covered the historic tile with a stick laminate type flooring. They changed their original location of the bathroom. The exposed mixture of brick and plaster was left visible, as well as the marble. We are currently waiting for the update on their exterior plans. Their sign was approved during the September Planning & Zoning meeting.
- Chunn Building Johnny Fuller's son Toby Fuller owns the building. They seem to have good plans for it; main floor is to be a business with at least one apartment upstairs. They are working on getting the building cleaned up before we have access to go in and look around.
- Old Fire Station Johnny Fuller purchased this month.
- Old City Hall / Police Department There is shown interest in purchasing, with a
  possible offer on the table. They want it because of the Coca-Cola connection. Possibly
  going to be converted to offices. We need to get in there and remove any lingering
  historic items in the cases.
- Zoning Overlay will discuss during the November meeting with Mayor Steve Ledbetter.
- Robert Lovett Candace brought up a proposal to make Mr. Lovett the official Historian of Woodbury. It would bee a good thing to do for him as well as the city. The HPC (Historic Preservation Commission) is the correct party to initiate bringing the idea to Council. He has brought up wanting to tour Woodbury while recording historic facts. Will work on naming something of the city in his honor.

We need historic photos of downtown Woodbury. How do we acquire and who should be asked? Check multiple Facebook pages for Woodbury and Historical Georgia, as well as Nancy Elrod, Valeta Mills, Pinky Elliott, Cindy, Janet Morgan, Kay Barnes, Joyce Gill, Devivo, Gene Hudson and old newspapers.

We need to collect them all by October 15th.
