MAYOR'S UPDATE

- PlanFirst Community Designation Application update
 - Ready to submit the application, if approved the city will be able to apply for CDGB grants every year
- Downtown Parking and Transportation Improvement Project Update
 - Will start in a couple of weeks
- Emergency Sewer Line pricing & Discussion
 - There were 7 companies that submitted bids on this project. The lowest bid was Crawford Grading at \$98,950.00.
 - Councilmember Ledbetter made the motion to accept the Crawford Grading bid at \$98,950
 - Councilmember Carter seconded the motion.

- Comprehensive Plan, Line-by-line review of the Community Work Plan (5-Year Short-term Work Plan). Council was asked for input and the Mayor shared that the City is currently at 68% complete for the plan and reminded Council of the need to ask Three Rivers Regional Commission for support in updating the CWP.
- The City received bids for repairing the 2 sets of tennis courts located on Main Street, the lowest bid was \$98,000
 - Councilmember Carter made a motion to look at just paving one of the Tennis Courts, if the bid would be under \$50,000
 - Councilmember Ledbetter seconded the motion
 - All approved
- There has been several discussions and meetings about the AgTech Innovation Center and the possible location of the Center at George Washington Elem school.

During his visit last week, State Representative Drew Ferguson talked about allocating earmark funds for the AgTech Innovation Center. The City should invest money to bring the Center to Woodbury. The City of Luthersville voted during their April 2021 City Council meeting to donate \$500 toward a grant writer.

TRI-CITY HOUSING-APPOINTMENT TO THE BOARD

Ms. Vicki Alston, Executive Director

Ms. Alston was asked to attend the Council meeting to discuss the appointment of a resident from Woodbury to the Tri-City Housing Authority Board. Ms. Alston presented the council with the by-laws of Tri-City Housing for their records. Ms. Alston indicated that one person that is currently on the board is a resident of the Housing Authority, but they need a second person appointed by Council. The Council decided not to reappoint Ms. Whitehead. Ms. Alston advised the council that Ms. Whitehead never showed up for any of the meetings and that she was glad the Council was making a new appointment.

Councilmember Carter recommended that the Mayor appoint Ms. Carolyn Ellison to the Tri-City Housing Authority Board. The Mayor agreed and offered Ms. Carolyn Ellison as his appointee to the Tri-City Housing Authority Board.

COLLETTE BERREYESSA-PROPOSED SENIOR CENTER

Ms. Berreyessa spoke approximately 8 minutes about a Senior Center at the George E Washington Elementary School, that she could make into a "mega-center" for seniors. She indicated that she has spoken with Abby Cox, [Director of the Department of Human Services, Division of Aging Services (DAS)] who has ensured her that funds are available for such a center. Ms. Berreyessa stated she has the education to operate such a facility.

When asked by Councilmember Garrett, Ms. Berreyessa stated that she did not have any documentation for council, but she would be able to provide the documents for Council to review.

Ms. Berreyessa advised the council she was disappointed the council decided to move forward with using taxpayer's money to fund a grant writer for the AgTech Innovation Center. She wanted the council to think about if they wanted a Senior Center or an AgTech Innovation Center to be located in the elementary school.

CAROLYN ELLISON-APPLICATION FOR WOODBURY DAY, JUNE 19, 2021

Ms. Ellison made application for "Woodbury Day." The event, if approved would be held on Saturday, June 19, 2021 from 1:00 pm until 8:00 pm. Ms. Ellison provided a copy of

an insurance policy for the Special Event and a list of Organizers. She also indicated that she paid for the permit and police staffing, paid for porta-potty's, and scheduled a clean-up crew.

The Mayor asked Chief Web for his recommendation to Council. Chief Web advised the Council during the past there were issues because there was no one taking responsibility or being held accountable for the event and, ultimately, the event got out of hand. Chief Web stated that he will be working closely with event sponsors to make this a fun time for the citizens. Chief Web assured Council there will be no alcohol sold or provided at the event and all officers will be on duty.

Police Department Report - April 19, 2021



During the month of March 2021, the Woodbury Police Department worked to resolve the calls for service for our citizens. According to our 911, CAD dispatch reports we were dispatched and answered approximately 181 calls for service ranging from "meet in person, suspicious activity, alarm, medical, reckless driving, damage to property, threats, civil service, domestic, follow ups, burglary, request extra patrol, house check, mechanical breakdown, unruly juvenile.

The Woodbury Police Department issued approximately 108 citations and 115 warnings. Our Department had two safety checkpoints.

The Woodbury Police Department utilized community service details to clean city streets, clean around city hall.

On March 30, 2021, the Woodbury Police Department in conjunction with FAT food ministry were able to provide our citizens with 300 boxes which consisted of meat, vegetables, and dairy products. I would like to thank Allen Kendrick and Doug Mathews for providing transportation to pick up and load this huge load of food for our citizens.

I would like to recognize The Boy Scouts of America Pack #104 for volunteering their outstanding service in helping with the community cleanup day organized by the Woodbury Police Department on March 20, 2021.
