If a landlord installs the tank for their rental property, the landlord may in writing forward the credit to their renter, but the landlord will not be allotted the credit(s) on his/her account at their location. If the landlord has the utilities in his/her name, the city will credit the customer's account at each location.

Kera Summers-DDA, 5-year revitalization Resolution, 1911 building lease, pending offer on old fire station and metal roof manufacturer moving into the west property of the old Nabisco plant. She also updated council on the donation from Georgia Power, Peaches in the Pines, and National Night Out.

Vicki Matthews — contract with Safe-built, building applications, timeline of pizzeria, mixed use of local property

Historic Preservation Commission

Candy Head — Historic districting in Woodbury, confirmation and election, rural opportunity zone, downtown plan with TSW, 1911 building preservation, Georgia Tech Strategic Priorities Assessment report.
