

MAYOR'S REPORT

Letter for Chief Wesley Favors

It is with much sadness to announce Wesley Favors retirement and it is my great pleasure to welcome him to the Woodbury Police Department Wall of Chief's.

For 28 years, Chief Favors has dedicated his life to the welfare and safety of our community and now he is requesting our support in his transition to life's next chapter.

It is my privilege to thank Chief Favors for the nearly three decades he has served our community. My request as the Mayor is that the Council recognize Chief Favors with a Woodbury Police Department Retirement Badge and as a gift of gratitude that we provide him with his duty weapon as a retirement gift on behalf of his many years of service.

To qualify as a retired law enforcement officer, the law requires that an individual:

- be separated from service in good standing with a government agency as a law enforcement officer for an aggregate of ten (10) years or more or separated from such an agency due to a service-connected disability after completing any applicable probationary period of such service;
- be authorized by law to engage in or supervise the prevention, detection, investigation, prosecution or the incarceration of any person for any violation of law:
- have had statutory powers of arrest or apprehension;
- is not under the influence of alcohol or another intoxicating or hallucinatory drug or substance; and
- is not prohibited by Federal law from possessing a firearm.

With those qualifications in mind, I would ask that the Council join with me through advice and consent to provide Chief Wesley Favors his retirement badge and allow me to draft a letter with the support of the City Attorney to provide him in kind his duty weapon.

- Update on Spectrum
 - Marcus Robinson, our Project Manager was out of the office for health reasons and our start-up date has been pushed until August 27th
- Update on Digital Sign Gran through USDA
 - USDA is asking that instead of the City receiving \$14,000 as a grant and contributing \$7,000 as our match we sign a \$7,000 loan with USDA. There is no early penalty for paying the loan back. Just as a reminder, Jimmy & Montez Sibley have agreed to pay the match on behalf of the City. Total for sign is \$21,000,
- Request to move City Owned Property to Woodbury Development Control
 - O I'm requesting to give ownership of all of the City owned property to the Woodbury Development Authority. The purpose for this move is to allow the Development Authority to control the growth of the downtown area, market the property, and have availability to work with the Department of Community Affairs to develop the downtown area in a planned manner. I would ask that the Council make a motion to move this property to the WDA control with the understanding that the WDA will need to provide a Brokers Price Opinion for each of the properties as they currently sit and when the property is sold the WDA will reimburse the City for each property at the BPO price. Should the WDA receive a price above the current BPO the WDA will be allowed to retain the difference.

Police Department Report

The plan was to have filming on Dromedary completed before the business in the downtown area opened at 9:00 am. Unfortunately, our work caused them to finish at 10:00 am.
- The rain that we had during the first of the month set us back on grass-cutting, but we used this time to begin cleaning the sidewalks on Main Street. Our plan is to have the sidewalks completed within the next few months.

- Update on Phase II Lift Station Upgrades, should be completed a month early
- Brad McConnell update on Water Tanks and Maintenance Proposal All water tanks have been completely cleaned out, the 70,000 gallon tank will be taken out of service.
 Brad informed the council that the tanks need to be under a maintenance program, the maintenance will include painting, keeping the tanks cleaned out and over all maintenance. The cost of the maintenance was discussed by the council to pay a one time fee \$205,000 and paying interest over 40 years or having a maintenance

contract over several years without interest. Quote on file
