High-Speed Internet Update
 The City of Woodbury will be recognized on January 28, 2020 as a Broadband
 Ready Community. Woodbury is the only city in the State with this recognition.

WATER & SEWER RATES & 2020 BUDGET

Chip McGaughey, P. E. Assistant Vice President, EMI

Mr. McGaughey updated the council on the water/sewer rates and budget for 2020. With all the upgrades already in place and the future upgrades that are needed, the water and sewer rates need to be increased by 35% sewer and 22% water in order to cover the already existing debt and future debt of the sewer and water upgrades. GEFA requires a 1.05 ratio on loans, there needs to be at least 5% more revenues than expenses. After several minutes of discussion in work session and council meeting on implementing the new rates, Councilmember Carter suggesting only a 18.5% increase now and the rest next year. If the city does not increase the rates the city will be in violation of the loan agreement with GEFA and USDA.

Councilmember Garrett made motion to increase the water/sewer rates and come back to council for 2021 rates

The Election law changed from Municipalities to refer to state law for elections of 4 years to Municipalities refer to the Charter, the city never changed the charter from 2 years to 4 years
